COOKIES

SERVER LOGS

NuPark uses Log analysis tools to create summary statistics, which are used for purposes such as assessing what information is of most interest, determining technical design specifications, and identifying system performance or problem areas. User Client hostname - The hostname (or IP address if DNS is disabled) of the user/client requesting access.

HTTP header, "user-agent" - The user-agent information includes the type of browser, its version, and the operating system it is running on.

HTTP header, "referrer" - The referrer specifies the page from which the client accessed the current page.

System date - The date and time of the user/client request.

Full request - The exact request the user/client made.

Status - The status code the server returned to the user/client.

Content length - The content length, in bytes, of the document sent to the user/client.

Method - The request method used.

Universal Resource Identifier (URI) - The location of a resource on the server.

Query string of the URI - Anything after the question mark in a URI.

Protocol - The transport protocol and version used.

PERSONALLY IDENTIFIABLE INFORMATION

What Personal Information We Collect

We collect personal information that you provide when using the Site. This information includes your first and last name, email address, mailing address, telephone number, identification numbers, vehicle descriptions and license plate number(s). You can browse this Site without creating an account, but you will need to create an account when you pay for citations or permits

or when you appeal a citation and in order to take advantage of certain features. We may ask you to confirm your personal information when you contact us. This will allow us to protect your confidentiality by verifying your identity.

Purchase Information

When you make a transaction with NuPark, we collect your name, IP address and payment method information, such as credit card confirmation. We collect this information in order to record your payment on your account. We also collect information that allows the parking operator to ship your permit. This includes the name, address, and phone number. None of your sensitive credit card information is processed or stored in our system. The credit card transaction is done with Authorize.net, an industry-leading third-party payment processor. Only the confirmation information regarding the payment is received back into our system, such as payment amount and confirmation number.

If you send us an electronic mail message with a question or comment that contains personally identifying information, or fill out a form that e-mails us this information, we will only use the personally-identifiable information to respond to your request and analyze trends. We may redirect your message to our client parking operator who is in a better position to answer your question. For site management functions, information is collected for analysis and statistical purposes. This information is not reported or used in any manner that would reveal personally identifiable information and will not be released to any outside parties unless legally required to do so in connection with law enforcement investigations or other legal proceedings.

Some of the information contained on the Web Servers is private information intended for specific individuals or departments. This may include accounting information, personnel information, or other items of a sensitive nature. This information is protected by passwords assigned to each individual who has need to access it.
